SCIENCE FAIR EVENT OF THE PASSAGEPLUS EVENTS ORGANIZING SERVICES

The PassagePlus Events Organizing Services will organize a Science Fair Event to be held in the select school's premises from January to March 2025.

The event aims to enhance educational opportunities by organizing structured science fairs that foster scientific inquiry and innovation among learners. These fairs actively engage them in hands-on learning, exploring advanced technologies, and applying practical skills to spark their interest and enthusiasm for science, technology, engineering, and mathematics (STEM) education.

The Science Fair Event will feature four dynamic stations showcasing emerging technologies in drones, robotics, virtual reality, and 3D printing, as follows:

Technology	Activity	Objective
Drones	Introduction to Drones: Hands-on Basics and Safety	Introduce learners to drone fundamentals, including safety protocols, basic handling, and essential flight skills.
Robotics	Robotics Basics: Build and Program with MBot	Introduce learners to fundamental robotics concepts, including the basic construction and programming of simple robots.
Virtual Reality	Explore Science Through VR: A Hands-On Virtual Experience	Introduce learners to virtual reality and allow them to explore scientific concepts through immersive VR environments.
3D Printing	3D Printing Basics: Design and Print Your Own Object	Introduce learners to 3D printing technology, guiding them through basic design and printing principles.
