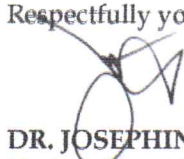

Free Entry, Working Prototype, Onsite Exhibit, and Live Demonstration

1. Purpose and Competition Structure

These guidelines govern competitive entries in the POTTE Bahandi Innovation Expo 2026. The Expo recognizes functional, original, safe, evidence-supported, and potentially useful innovations for education, industry, livelihood, and community development.

Important distinction: Innovation has no online qualifying presentation. Entries undergo administrative, technical, prototype-evidence, and safety screening. Accepted entries exhibit and compete onsite on December 8, 2026.

- Submit one complete Innovation Google Form response and all required files by November 7, 2026.
- The Secretariat checks eligibility, completeness, originality and IP disclosures, prototype evidence, and declared safety or technical requirements.
- Technical reviewers score eligible submissions. Accepted teams receive an exhibit confirmation and technical instructions.
- Accepted teams set up, staff, pitch, and demonstrate the same screened innovation onsite on December 8, 2026.
- Onsite exhibit and demonstration scores determine the official awards.

2. Eligibility, Team Members, and Entry Limits

- Eligible entrants include educators, students, researchers, trainers, practitioners, inventors, and qualified community or industry partners whose work fits an announced category.
- Each entry may have a maximum of five team members. Every listed member must have made a substantive contribution and approved the submission.
- A person may be included in up to two Innovation entries but may be team lead and primary pitch presenter for only one entry.
- Only individuals named in the Google Form before the deadline are eligible for official recognition. Post-deadline team changes require written consent and POTTE approval before judging begins.
- The same or substantially identical innovation may not be entered more than once, under several categories, or as both a research and innovation entry without written approval showing genuinely different outputs.
- An innovation previously presented, exhibited, or commercialized remains eligible only when fully disclosed. An entry that already received a Champion, First Place, Grand Prize, Best Innovation, or equivalent top national or international award is not eligible for the same Bahandi competitive award.

3. Entry Fee and Participant Expenses

Free Innovation entry: There is no separate Innovation Expo submission or competition fee.

Free entry does not automatically waive national-convention registration, travel, accommodation, meals, transport of the innovation, packing, insurance, equipment, consumables, internet, electrical adapters, or other personal and exhibit expenses unless POTTE confirms a specific item in writing.

1. Innovation Categories

- Agri-Fishery Arts and Food Systems
- Information and Communications Technology, AI, Robotics, and Digital Solutions
- Home Economics, Food, Fashion, Family, and Consumer Services
- Industrial Arts, Engineering, Fabrication, Construction, and Energy
- Entrepreneurship, Livelihood, Workforce, and Community Solutions
- Cross-Disciplinary, Inclusive, Green, or Emerging-Technology Innovation

Select one primary category. The Technical Committee may reclassify a multi-application entry before acceptance to ensure comparable judging. Commercial exhibitors, vendors, and sponsors are not automatically competitive entrants; they must submit an eligible entry and undergo the same screening.

2. Minimum Competitive Standard

Working output required: A purely conceptual idea, rendering, poster, literature review, or statement of expected outcomes is not eligible for competitive ranking.

1. The entry must be a working physical prototype, functional software or digital system, operational process, or demonstrable service model that performs its principal claimed function.
2. The team must provide credible evidence of testing, validation, user feedback, repeatability, cost or feasibility, and known limitations appropriate to the innovation's stage.
3. The actual innovation must be available for onsite inspection. A video may support but ordinarily may not replace the physical or live functional demonstration.
4. An adaptation or improvement must disclose the source technology and demonstrate a meaningful original improvement, new application, or measurable performance benefit.

Originality, Intellectual Property, Safety, and Responsible AI Use

1. All submitted text, data, images, designs, code, test results, and claims must be accurate, lawfully used, and properly attributed. Fabrication, falsification, plagiarism, unauthorized copying, or misrepresentation is prohibited.
2. An adaptation may qualify only when the source technology and third-party components are disclosed and the team demonstrates a meaningful original improvement or new application. Rebranding, simple kit assembly, or copying an online design is insufficient.

9 Exhibit, Booth, and Safety Mechanics - December 8, 2026

- Venue: Legazpi City Convention Center. Setup, judging window, exhibit hours, booth or table dimensions, dismantling time, available power, furniture, and loading access shall be stated in the acceptance notice or Exhibitor Technical Bulletin.
- Each team must remain within its assigned space and keep aisles, exits, fire equipment, and neighboring exhibits unobstructed. A maximum of three team members may staff the booth at one time unless POTTE approves an accessibility or safety exception.
- The same screened prototype or system must be available and operational during judging. Improvements to the same core innovation may be disclosed; a replacement product or materially different concept is not allowed.
- Open flames, explosives, weapons, flammable or toxic materials, exposed live wiring, unguarded moving parts, unsafe pressure vessels, high heat, hazardous radiation, and unsafe lasers are prohibited unless expressly approved with adequate controls.
- Food preparation or tasting, chemicals, biological materials, live animals, human-subject testing, medical claims, and high-power equipment require prior written approval and compliance with venue, health, sanitation, ethics, and safety rules.
- Electrical load, plug, internet, sound, battery, heat, liquid, and other technical needs must be declared in the form. Participants supply approved adapters, surge protection, charged batteries, offline backups, and special equipment unless POTTE confirms otherwise.

6. Submission Receipt, Screening, and Decisions

1. The Google Form timestamp is the official filing time. **Email and private-message** submissions are **invalid** unless POTTE announces a platform-outage procedure.
2. The Secretariat assigns a **permanent entry code only after checking the response** and payment. The participant-created title or payment reference is not the official entry code.
3. Administrative screening checks deadline, author limits, entry duplication, payment, required files, file access, blind formatting, disclosures, and applicable ethics documentation.
4. Technical screening evaluates eligible papers using the published 100-point rubric. A paper should earn at least 70 points to proceed to the online qualifier, subject to verification and program capacity.
5. Possible decisions are *qualified for online presentation, for limited compliance, not qualified, withdrawn, or disqualified*. A compliance notice permits only the stated correction by the stated time.

8. Online Qualifying Presentation - October 30, 2026

Purpose: The live Zoom round selects the Top 10 Research Finalists overall. It is mandatory for every entry qualified by the paper screening.

1. **Time:** seven minutes for presentation and three minutes for questions and answers. The presentation stops at seven minutes; material delivered after the stop is not considered.
2. **Presenter:** one officially registered author. A substitute must be another registered author and must obtain written approval before the assigned schedule, except in a documented emergency.
3. **Mode:** live camera-on presentation and screen sharing. A prerecorded clip may support but may not replace the live presentation and live defense.
4. **Equipment:** the presenter is responsible for a working device, camera, microphone, stable internet, power backup where practicable, and a locally saved copy of the slides.
5. **Participant-side interruption:** one reconnection opportunity of up to three minutes may be granted. If the presenter cannot return, judges score only the evidence delivered; a repeat presentation is not guaranteed.
6. **Organizer-side interruption:** the timer pauses. The Session Chair may resume or reschedule the affected entry using a remedy applied consistently to comparable cases.
7. **Attendance:** the presenter must enter the Zoom room at least thirty minutes before the assigned time and remain available until released. Absence after two official calls is recorded as a no-show.



8. Recording: POTTE may record the session for documentation, score verification, and authorized non-commercial event reporting.

Top 10 Selection

1. The Top 10 are selected overall across all streams and tracks using the average of at least three valid online-qualifier scores.
2. No stream or track has a reserved finalist slot. The same rubric is used for all entries.
3. An entry should earn at least 70.00 points to be named a finalist. POTTE may name fewer than ten finalists if fewer than ten entries meet the quality and eligibility standards.
4. A tie for tenth place is resolved by Research Rigor and Methodology; Analysis, Results, and Conclusions; Originality and Significance; Question-and-Answer Defense; then a documented panel decision.
5. Online scores are used only to select finalists and are not added to onsite scores.

10 Onsite Top 10 Final Presentation

1. Mode and venue: onsite during 8th POTTE National Convention, December 7-9, 2026, at Legazpi City Convention Center. The exact session date, room, and reporting time shall be stated in the finalist notice.
2. Time: ten minutes for presentation and five minutes for questions and answers. Signals are given at eight and ten minutes, and the presentation stops at ten minutes.
3. Slides: A maximum of 12 content slides is recommended, excluding the title and references. Slides must be consistent with the accepted paper and properly cite third-party content.
4. One of the approved authors is the primary presenter. A second registered author may assist during questions and answers only when permitted by the Session Chair.
5. A finalist must confirm attendance and comply with the convention registration and finalist instructions in the finalist notice. The P500 research fee does not include convention registration or personal travel expenses.
6. A finalist who withdraws or fails to confirm by the stated deadline may forfeit the slot. POTTE may invite the next highest-ranked eligible entry before the final roster is locked.
7. Substantial changes to the research question, data, methodology, authorship, or core findings after qualification are prohibited. Only corrections and clearer presentation of the same accepted study are allowed.

3. At least three valid judge scores must remain for official ranking; otherwise, a qualified alternate judge shall be assigned.

4. The Secretariat shall compute the arithmetic mean of all valid total scores and round the result to two decimal places.
5. Canvassing, gifts, pressure, private contact with judges regarding scores, or attempts to obtain confidential judge assignments are prohibited.
6. Participation does not guarantee an award. POTTE may withhold a competitive award when no eligible entry earns at least 75.00 points or when the mandatory competition standard is not met.

Tie-Breaking

If totals are equal to two decimal places, the tie shall be resolved in this order: Research Rigor and Methodology; Analysis, Results, and Conclusions; Originality and Significance; Question-and-Answer Defense; then a documented panel decision.

Limited Score Verification or Protest

1. A participant may submit one signed written request within thirty minutes of onsite posting or within twenty-four hours of an emailed or online result.
2. Permissible grounds are a mathematical or tabulation error, mistaken entry identity, documented eligibility issue, undisclosed conflict of interest, or material failure to follow a published procedure.
3. A judge's academic or technical judgment is not appealable. A participant may not demand another entrant's score sheet, confidential notes, or personal information.
4. The Appeals Committee shall verify the record. Its written ruling is final, subject to later disqualification for fraud, plagiarism, falsification, safety violations, or ineligibility.
