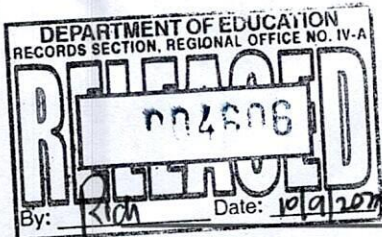

In support of the Memorandum of Agreement (MOA) between Goethe Institut-Philippinen and the Department of Education (DepEd), the **2023 Science Film Festival (SFF)** with the theme: **'United Nations Decade on Ecosystem Restoration'** shall be conducted from October 25 to December 1, 2023. The Festival aims to promote science literacy and enhance awareness of contemporary scientific, technological, and environmental issues through the medium of film and television.

In this regard, learners from both public and private secondary schools particularly the Regional Science High Schools (RSHSs), Legislated Science High Schools (LSHSs), Science, Technology, and Engineering (STE) - implementing schools, and Special Science Elementary Schools (SSES) are invited to watch the films.

Goethe Institut Philippinen will provide a USB flash drive containing all the films for primary and secondary groups. The USB will be distributed to all Regional Offices. Upon receipt of the USB, the Regional Focal Person shall distribute the USB to the schools that will hold the SFF screenings within the festival period from October 25 - December 1, 2023. All USB items shall be returned to the DepEd Central Office on or before December 10, 2023, and shall include a written report on the total number of viewers for the entire festival duration.

All expenses incurred in the distribution of the USB to the different schools and the return to the Central Office shall be charged against the respective office's available MOOE, and other local funds subject to the usual accounting and auditing rules and regulations. The post-screening science activities (games and simple experiments) will also be made available online through this link www.sciencefilmfestival.org. These activities are developed to enhance the science learnings from the films.

Participation of learners shall be subject to a no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*. The activity is also subject to a no-collection policy as stated in Section 3 of Republic Act No. 5546, *An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever*
