**DIVISION JOINT EVALUATION, VALIDATION AND OCULAR INSPECTION OF
PRIVATE SCHOOLS APPLYING FOR NEW AND RENEWAL OF
GOVERNMENT PERMIT FOR SY 2026-2027**

1. In line with the mandate of the Department of Education to ensure quality education, safety, and compliance with existing laws, rules, and standards governing private schools, this Office hereby issues this Memorandum to inform all concerned of the conduct of a **Division Joint Evaluation, Validation, and Ocular Inspection of Private Schools from January 12 to February 27, 2026**.
2. The activity aims to:
 - a. Validate the authenticity and completeness of documents submitted by private schools relative to their application for Government Permit, or other regulatory requirements;
 - b. Assess compliance with curriculum standards, instructional requirements, and staffing qualifications;
 - c. Inspect school facilities, safety measures, health standards, and learning environment; and
 - d. Ensure adherence to existing DepEd Orders, Memoranda, and relevant laws and regulations.
3. The following are the composition of the SDO Inspectorate Team:
 - a. Mario B. Maramot, OIC Chief, SGOD or Alternate SGOD Personnel
 - b. Marian L. Arias, Education Program Supervisor
 - c. David M. Nuay, Chief, CID or Alternate Education Program Supervisor
 - d. Public Schools District Supervisor of concerned Sub-Office or Principal Coordinator
 - e. Cora V. Samson, Senior Education Program Specialist (SMME)
 - f. Jessa S. Guerra, Education Program Specialist (SMME)
4. The school owner, an incorporator and/or a member of the Board of Trustees are advised to be in the school during the conduct of inspection. In the event that any of these officials will not be available, a certification from them, authorizing the present school personnel to sign for and in their behalf and to deal with the inspectorate team, shall be presented. It is therefore understood that failure of the school to meet these conditions may compel the team to defer the conduct of the said task.

5. Travelling and other expenses of SDO personnel relative to the conduct of this activity shall be charged against Division MOOE funds subject to usual accounting and auditing rules and regulations.
