SCHOOL DENTAL HEALTH CARE PROGRAM DEPLOYMENT SCHEDULE

1. Pursuant to DepEd Order No. 041, s. 2020 entitled Guidelines on the Implementation of the School Dental Health Care Program Section V-A, to ensure scheduled deployment plan of health personnel. (Enclosure)

2. As we continue to prioritize the overall well-being of our personnel, it's essential to address all aspects of their health, including dental care. While some schools in our district may not have dental clinic readily available, Division Dentist has taken proactive steps to ensure access to dental examination and treatment for our DepEd personnel who may not have convenient access to dental clinic facilities.

3. Services offered:

- a. A range of dental services will be available, including dental check-ups, fluoride application, tooth extraction, consultations and referral system.
- b. Address both routine dental care needs and any specific concerns raised by DepEd personnel during scheduled appointments.

4. Medical Clearance:

Before undergoing tooth extraction, all personnel with underlying medical condition must obtain a medical clearance from their physician first. This step ensures that any existing medical conditions are taken into account and that the procedure is safe for each individual.

5. Action Required:

School Principals: Please inform your teaching and non-teaching staff about this dental service initiative. Encourage them to seek medical clearance if needed.

DepEd Dentists: Prepare the necessary equipment and coordinate with the schools in your assigned district. Ensure that the tooth extraction services are conducted efficiently and professionally. Personnel: If you plan to undergo tooth extraction,
