JOINT EVALUATION, VALIDATION, AND OCULAR INSPECTION OF PRIVATE KINDERGARTEN/ELEMENTARY/JUNIOR AND SENIOR HIGH SCHOOLS APPLYING FOR GOVERNMENT PERMIT FOR SY 2023-2024

- **TO:** Assistant Schools Division Superintendents Chief Education Supervisors, SGOD and CID Education Program Supervisor In-charge of Private Schools Public Schools District Supervisors Private Elementary and Secondary School Heads All Others Concerned
- 1. In order to validate the compliance of private schools to quality standards set by the Department of Education (DO No. 88, s. 2010), the DepEd Batangas Province Monitoring Team will conduct evaluation, validation, and ocular inspection of private schools applying for Government Permit for **SY 2023-2024** as per attached list on **February 13, 15,16 and 28, 2023**.
- 2. The Inspectorate Team shall be composed of the following:
 - 1. Education Program Supervisor I In-charge of Private Schools;
 - 3. Public Schools District Supervisor (PSDS); and
 - 3. School principal of a public school near the location of the private-school applicants.

They shall perform the joint tasks to ensure the compliance to the documents and facilities requirements of the level/course/track/strand being applied for.

- 3. The school owner, an incorporator and/or a member of the Board of Trustees are advised to be in the school site during the evaluation, validation, and ocular inspection. In the event that any of these officials will not be available, a certification from them authorizing the present school personnel to sign for and in their behalf and to deal with the Inspectorate Team shall be presented. It is therefore understood that failure of the school to meet these conditions may compel the Team to defer the conduct of the said tasks.
