1. The **Philippine Educational Placement Test (PEPT)** is a DepEd national assessment that determines appropriate grade placement or educational recognition for learners who have not completed formal basic education. This memorandum sets out the schedule for PEPT activities.
2. To ensure efficient and compliant implementation of all related activities, the following schedule is hereby issued:
3. For **Document Validation**: Bring all necessary checklists, application forms and reference guidelines. Ensure all applicant documents meet eligibility criteria.
4. For **Orientation**: Attendance is mandatory. Participants must review the PEPT Handbook prior to the session and come prepared with questions.
5. For **Test Administration**: Report one (1) hour before the start time, 7:00 am. For the smooth flow of the examination, the examinees are advised to bring their own snacks and lunch.
6. All concerned personnel are advised to coordinate with the Division Testing Coordinator, Curriculum Implementation Division for any queries to confirm their assignment. This serves as Travel Order of all the testing personnel.
7. Please ensure full compliance with the schedule to establish smooth implementation off all PEPT activities.
