As part of the Department of Education's continuing efforts to significantly improve learning outcomes and pursuant to **DM 001, s. 2025: Operational Guidelines Implementation Support to School for Improved Learning Outcomes**, and **DM 008, s. 2025: Conduct of Student Learning Sessions to Enhance Higher Order Thinking Skills and Improved Learning Outcomes**, Schools Division Office of Batangas Province through Curriculum Implementation Division shall conduct the following activities:

- a. assign Learning Session Expert per school to assist the activities of the learners,
- b. assign International Large Scale Assessment Adviser (ILSA) per school to monitor organize learning sessions for English, Science, and Mathematics (ESM) for students, and
- c. conduct Learning Sessions starting January 13, 2025.

3. Participating schools in the ILSAs shall conduct learning sessions, including the provision of meals for volunteer teachers and learners, communication allowance for the Learning session Experts, production of required learning materials during the sessions, and materials for recognizing participating learners.
 4. Learners actively engaged in readiness activities for ILSAs shall be exempt from participating in the activities outlined in DepEd Order No.9, s, 2024. This exemption ensures learners to dedicate their time and focus to readiness activities without conflicting obligations.
 5. All personnel involved in the support activities has a provision of communication expenses, not exceeding Php300 per month, the transportation expenses of Learning Session Experts not exceeding Php 200 per learning session, and Php 300 for every learner as meal allowance per learning session shall also be provided.
 6. Expenses relative to the conduct of the activities in support of improved learning outcomes shall be charged to Sub-ARO Numbers: RO-4A-25-0002, RO-4A-25-0017, RO-4A-25-0018, and OSEC-4A-25-00063 subject to existing accounting and auditing guidelines and procedures.
 7. Concerned School Head/Accountable Officer of the recipient schools are advised to prepare Supplemental Annual Procurement Plan (APP) and ensure the sufficiency of fidelity bond. Downloading of funds will be done simultaneously with school MOOE.
 8. Attached is the breakdown of allocation per school during the implementation of the program.
 9. Immediate dissemination and strict compliance with this Memorandum are earnestly desired.
