SUBMISSION OF REQUIREMENTS FOR PLANTILLA ALLOCATION LIST AND RECLASSIFICATION OF TEACHERS AND SCHOOL HEAD POSITIONS

- 1. In order for the Division Office to determine the number of applications for the reclassification during the election prohibition, this Office announces the resumption of requirements submission for the Plantilla Allocation List (PAL) and Reclassification starting **March 12, 2025**.
- 2. All concerned school heads and teachers are advised to submit the list of requirements attached to this memorandum (Please see Enclosure 1) to process the Plantilla Allocation List.
- 3. For ease of consolidation and retrieval, the following steps shall be undertaken:
 - 3.1. Applicants are advised to put index tab/ custom tab dividers for ease of identification and checking.
 - 3.2. Service Records must be updated in the current year (NBC No. 597)
 - 3.3. For Head Teacher, Master Teacher and School Principal positions, the Division Office shall provide the approved Comparative Assessment.
- 4. Applicants for School Principal I position should be in the current comparative assessment results, have obtained at least 60 points, and meet the following basic requirements as per DepEd Order 97 s 2011:

Education: Master's Degree in the field of Administration, Supervision, Leadership or Management;

Experience: Two (2) years as Head Teacher III for elementary; Two (2) years as Head Teacher VI for Secondary

Training: 48 hours of relevant training initiated, sanctioned, approved/recognized by DepEd not used in the immediate previous promotion
