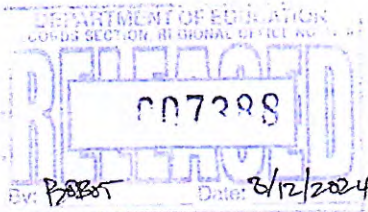



1. This has reference to DepEd Order No. 88 s. 2010 entitled 2010 Revised Manual of Regulations for Private Schools in Basic Education. Section 25 of the Order states that "All private educational institutions shall be subject to reasonable supervision and regulation by the Department." Anent to this, this Office announces the conduct of monitoring to all private schools from **March 13-22, 2024**.
2. The said monitoring activity shall be done by the Joint Monitoring Team composed of representatives from the Regional Office (RO) and the Schools Division Office (SDO).
