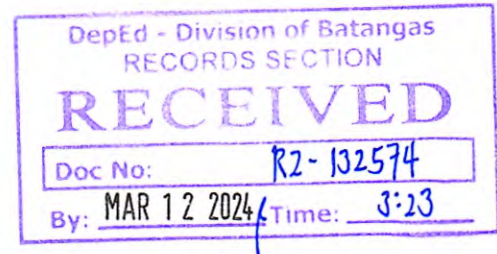

**ADMINISTRATION OF THE NATIONAL ACHIEVEMENT TEST FOR  
NAT G6 (NAT G6) AND ELLNA SY 2023-2024**

1. In reference to DepEd Memorandum No. 016, s 2024, the Department of Education (DepEd) through the Bureau of Education Assessment (BEA) with the assistance of division public and private elementary school personnel shall administer the **National Achievement Test for Grade 6 (NAT G6)** and **Early Language, Literacy, and Numeracy Assessment (ELLNA), School Year 2023-2024**.
2. The conduct of tests is pursuant to D.O. 022, s.2023 titled **Implementing Guidelines on the School Calendar of Activities for the School Year 2023-2024** and **DO.003, s. 2024** titled **Amendment to DepEd Order No. 22, s. 2023 (Implementing Guidelines on the School Calendar of Activities for the School Year 2023-2024)**.
3. As stated in DO 29, s. 2022 titled **Adoption of the Basic Education Monitoring and Evaluation Framework**, DepEd must identify and articulate performance indicators and outcomes for measuring performance in the development of plans and policies. These indicators and outcomes will be used for the assessment of the effectiveness and efficiency of the delivery of education services. The results of system assessments will serve as evidence for the improvement of the curriculum implementation.
4. The **ELLNA** will be administered in the current Grade 3 enrolled learners to determine if students are meeting the learning standards in early language, literacy, and numeracy. The test is in a multiple-choice item format. Moreover, English, Filipino, and Mother Tongue shall be the languages for this assessment.
5. Further, the **NATG6** will be administered to sampled Grade 6 learners in all schools' division offices SDOs in public and private schools through a

paper-based modality and shall cover using learning areas English, Mathematics, Science, Filipino, and Araling Panlipunan as content. The test design is progressive in nature wherein test items measure varying level of skills.

6. These assessment programs will be administered on a **paper-based modality** to all regional offices (ROs), schools' division offices (SDOs), and schools.
7. In accordance with DO. 027, s.2022 titled **Conduct of Rapid Assessment in School Year 2021-2022 for Learning Recovery as well as Preparation for the 2024 Baseline System Assessment**, the current Grades 3, 6, learners of the present School Year will be taking the assessments.
8. Relative to the activity, there will be a **virtual orientation** of all elementary school heads in both **public & private schools** on **March 22, 2024, 8:00 A.M.** Meeting link will be sent to the official group chat using Microsoft Office 365. Elementary School Heads are advised to ready their hard copy of the assignment of **external** room examiners & room supervisors in the administration of test.

11. Expenses incurred during the conduct and attendance to this activity shall be charged to local/MOOE funds subject to usual accounting and auditing rules and regulations.





