In reference to DepEd Memorandum No. 040 s.2024, this office hereby informed the Division Online Administration of the **National Learning Camp Assessment (NLCA)** for School Year 2024-2025 from **March 11- April 12, 2024 (Pre-Test) and April 15- May 17, 2024 (Post Test)** through the National Education Portal (NEP).
  2. The field is hereby advised to administer the **National Learning Camp Assessment (NLCA) Pre-test starting March 20, 2024.**
  3. The assessment will be administered through an online computer-based modality for all Grades 7 to 10 public school learners. The assessment tool is designed to identify the effectiveness of the learning camp intervention on the learning proficiencies of the participating learners before and after attending the said program.
  4. The test shall cover learning areas in **English, Science, and Mathematics**, wherein test items measure varying levels of skills and competencies in a multiple-choice format using the English language.
  5. Public Junior High Schools (JHSS) Principals / School Heads are advised to make necessary adjustments / mechanism in adherence and follow strictly to the DepEd Order (DO) No.9, s. 2005, titled "Instituting Measures to Increase Engaged Time- On- Task and Ensuring Compliance Thereto.
  6. Health and safety protocols must be followed in all activities related to the national test administration.
