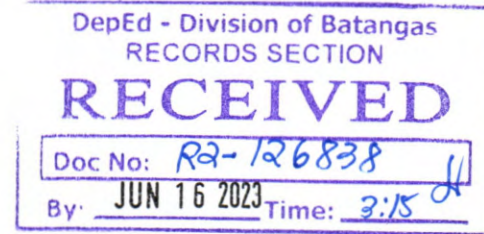

CONSULTATION CONFERENCES FOR THE ENHANCEMENT OF DEPED ORDER NO. 40, S. 2012, OTHERWISE KNOWN AS THE "DEPED CHILD PROTECTION POLICY"


1. Pursuant to DepEd Order (DO) No. 3, s. 2021, or the Creation of Child Protection Unit (CPU) and the Child Rights in Education Desk (CREDe) in the Department of Education (now Learner Rights and Protection Office), which mandates the said Office to formulate policies concerning all matters pertaining to the right of the child in basic education to protection from all forms of violence, abuse, neglect, cruelty, exploitation, and maltreatment, consistent with the overall framework of the Department to realize child rights in basic education. Towards this end, DO No. 40, s. 2012, or the DepEd Child Protection Policy shall be enhanced to comply with new laws and to improve the preventive and responsive mechanisms to ensure the protection of learners from all forms of violence, abuse, neglect, cruelty, exploitation, maltreatment, and other conditions prejudicial to their development.
2. Schools Division Office of Batangas Province is one of the 31 SDOs in the Philippines to conduct consultation conference for the enhancement of DepEd Order No. 40, S. 2012 otherwise known as the "DepEd Child Protection Policy". This Conduct of Consultation Conferences primarily aims to seek the perspective of learners considering that they are the main subject of the Child Protection Policy and with the following members of the CPCs in schools: a. School Head/Administrator; b. Guidance Counselor/Teacher; c. Representative of the Teachers as designated by the Faculty club; d. Representative of the Parents as designated by the Parents-Teachers Association; e. Representative from the Community as designated by the Punong Barangay, preferably, a member of the Barangay Council for the Protection of Children.
3. Participants to this activity are fifty (50) learners coming from Malaking Pook NHS and fifty five (55) adults from the members of the CPCs in schools. Attached is the list of attendees **Annex A** for reference. Learner participants must come in their school uniform.

4. Likewise, the activity shall be led by the SDO Learner Rights and Protection Focal Person, Rosemarie J. Gonzales. The Program Management Team is attached as **Annex B** and Program schedule as **Annex C**.
5. To ensure the smooth conduct of this activity, a virtual coordination meeting of all facilitators shall be held on June 28, 2023 at 1:00 p.m. Meeting link shall be sent to the concerned individuals.
6. Also attached in this memorandum is the copy of the Parent's Permit **Annex D** to be secured by Malaking Pook NHS.
7. Expenses such as meals, materials, transportation of the facilitators and other incidental expenses relative to the conduct of this activity shall be charged against SUB-ARO downloaded by the Central Office. Transportation expenses of the learners and adult participants may be charged against local funds, both subject to usual accounting and auditing procedures.
8. Teaching personnel who will participate in this activity are entitled to service credit as per DepEd Order No. 53, s. 2003 while non-teaching and teaching-related personnel are entitled to compensatory time-off as stated in CSC and DBM Joint Circular No. 2, s. 2004.
9. Immediate and wide dissemination of this Memorandum is desired.
