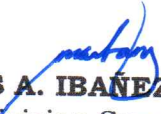

4. The food and accommodation of the official participants: five (5) campus journalists, and one (1) SPA in the individual category, shall be covered by the Regional Office through the NSPC fund.
5. Transportation expenses of the five (5) campus journalists shall be charged against the NSPC fund downloaded to the division office through the Special Allotment Release Order (SARO). Meanwhile, the transportation expenses of the SPAs in individual and group events, with the Education Program Supervisors in English and Filipino, shall be charged to the division MOOE, including the additional fund for the transportation expenses of the five (5) campus journalists. Other related expenses shall be charged to local funds/MOOE, LGU/Special Education Fund, and other available funds, subject to the usual accounting and auditing rules and regulations.
6. Similarly, travel and related expenses of the other NSPC delegates shall be charged against local funds/MOOE, LGU/Special Education Fund, and other available funds, subject to the usual accounting and auditing rules and regulations.
7. The official participants in the photojournalism and radio broadcasting categories shall be at the venue in Vigan City, Ilocos Sur, on *May 18, 2025*, for the checking of cameras, laptops, and other equipment needed in the competition.
8. This memorandum serves as the participants' travel order.
9. Immediate and wide dissemination of this memorandum is desired.
