# JOINT EVALUATION, VALIDATION, AND OCULAR INSPECTION OF PRIVATE KINDERGARTEN/ELEMENTARY/JUNIOR AND SENIOR HIGH SCHOOLS APPLYING FOR GOVERNMENT PERMIT FOR SY 2022-2023

TO: Assistant Schools Division Superintendents
Chief Education Supervisors, SGOD and CID
Education Program Supervisor In-charge of Private Schools
Public Schools District Supervisors
Private Elementary and Secondary School Heads
All Others Concerned

- 1. With reference to DepEd Order No. 88, s. 2010, "2010 Revised Manual of Regulations for Private Schools Basic Education", and Regional Memorandum No. 10, s. 2022 "Transitory Guidelines for Processing New Government Permit, Renewal Permit and Government Recognition for SY 2022-2023", the DepEd Batangas Province Inspectorate Team will conduct evaluation, validation, and ocular inspection of private schools applying for Government Permit for SY 2022-2023 as per attached list from July 6, 2022 to August 5, 2022 (Enclosure 1).
- 2. The SDO Inspectorate Team (per private school) shall be composed of at least three (3) persons from among the following personnel:
  - 2.1 CID Chief
  - 2.2 Division Private School Coordinator
  - 2.3 Education Program Supervisor
  - 2.4 Senior Education Program Specialist
  - 2.5 Education Program Specialist II
  - 2.6 Public Schools District Supervisor\*
  - 2.7 Public Elementary or Secondary School Head

\*The PSDS to be assigned must preferably be the PSDS of the school district where the private school to be inspected is located.

- 3. There will be a virtual orientation for inspectorate team on July 11, 2022 at 9 AM regarding the checklist and guidelines to be used by the team during the ocular inspection. Link shall be given before the scheduled date.
- 4. The school owner, an incorporator and/or a member of the Board of Trustees are advised to be in the school site during the evaluation, validation, and ocular inspection. In the event that any of these officials will not be available, a certification from them authorizing the







present school personnel to sign for and in their behalf and to deal with the Inspectorate Team shall be presented. It is therefore understood that failure of the school to meet these conditions may compel the Team to defer the conduct of the said tasks.

- 5. Health protocol as per policies and guidelines set by the IATF shall be strictly implemented.
- 6. Expenses incurred relevant to the conduct of the activity will be charged against division and school MOOE subject to the usual accounting and auditing procedures.
