GMRC/EsP AND VALUES EDUCATION COORDINATION MEETING

1. The Schools Division Office of Batangas Province will conduct a coordination meeting with designated sub office coordinators of GMRC/EsP and Values Education in both elementary and secondary public schools with Values Education head teachers. This activity is designed to strengthen implementation strategies, review current practices, and prepare for the succeeding school year in alignment with the Enhanced K-12 Curriculum and division initiatives.

2. The meeting aims to present a comprehensive report on the teaching and learning process for School Year 2024–2025, with particular focus on instructional delivery, assessment practices, and learner engagement in GMRC/EsP and Values Education. A key agenda item includes sharing updates on the implementation of the Retrospect Batang Batangueño Character Development Program, highlighting accomplishments, challenges, and insights. Additionally, participants are expected to report on the conduct and results of the Values Education/EsP Proficiency Examination to support data-driven planning and instructional enhancement.

3. The meeting will also address the preparation and development of learning resources and instructional materials to ensure alignment with national and division standards. Furthermore, participants will engage in planning for School Year 2025–2026, guided by a data-informed approach. This includes the comparative analysis of Mean Percentage Scores (MPS) for SY 2023–2024 and SY 2024–2025, Competencies' level of mastery, updates on Dangal EsP implementation, documentation of best practices, the number of teachers trained, identification of out-of-field teachers, utilization of Assessment Coursework, and the formulation of relevant plans based on the gathered data.

4. The coordination meeting is scheduled on May 18 (Congressional District 1), May 19 (CD 2), May 20 (CD 3), and May 21 (CD 4), 2025. Specific venues for each district will be communicated directly to the concerned participants through personal messages to ensure convenience and accessibility. Please be advised that this activity is non-budgeted; hence, food provision shall be on a bring-your-own or participant's arrangement basis.
