1. Pursuant to the continuous strengthening of policies and procedures in the implementation of programs and activities of the Department of Education, this Office shall conduct the Division Online Re-Orientation on DepEd Order No. 040, s. 2014 "*Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public Schools Annexes in Basic Education*" and DepEd Order No. 051, s. 2015 "*Guidelines on the Implementation of Senior High School (SHS) Program in Existing Public Junior High Schools (JHSs) and Integrated Schools (ISs), Establishment of Public Stand-Alone SHSs, and Conversion of Public Elementary and JHSs in Stand-Alone SHSs*", on **May 19, 2026** at 9 o'clock in the morning onwards.
2. The activity aims to:
  - a. revisit the salient provisions of DepEd Order No. 040, s. 2014 and DepEd Order No. 051, s. 2015;
  - b. ensures uniform understanding and proper application of the prescribed guidelines and procedures;
  - c. clarify issues and concerns encountered during the implementation of related activities and programs; and
  - d. strengthen compliance among concerned personnel.
3. Participants to this activity are all Public Schools District Supervisors (PSDS) and sub-offices committee, Division Review and Evaluation Committee (DREC) Members, and other concerned personnel.
4. The online platform to be used, together with the meeting link, shall be communicated through a separate advisory.
5. Participants are expected to attend the activity in full and ensure stable internet connectivity throughout the duration of the orientation.
6. Immediate and widest dissemination of this Memorandum is desired.
