RECOMPOSITION OF THE DIVISION COMMITTEE ON DECORUM AND INVESTIGATION (CODI)

- 1. Section 14, Rule 3 of the 2017 Rules on Administrative Cases in Civil Service (2017 RACCS) mandates the creation of a Committee on Decorum and Investigation (CODI) in all national and local government agencies, state and local colleges and universities, and government-owned and controlled corporations with original Charters.
- **2.** The creation of the CODI would serve as an independent internal grievance mechanism to address cases involving Gender Based Sexual Harassment (GBSH) as directed by Section 33 of the Implementing Rules and Regulations of the Republic Act No. 11313, otherwise known as the Safe Spaces Act.
- **3.** In line with this, DepEd Batangas Province announces the Recomposition of the Division Committee on Decorum and Investigation (CODI):

- **4.** As provided for under the 2017 RACCS and the IRR of RA 11313, the Division CODI shall perform the following functions:
 - a. Receive complaints of sexual harassment/GBSH committed in the Division Office;
 - b. Investigate sexual harassment/GBSH complaints, including preliminary investigation in accordance with the prescribed procedures;
 - c. Submit a report of its findings with corresponding recommendations to the disciplining authority for decision
 - d. Lead in the conduct of discussion about sexual harassment/GBSH within the agency or institution to increase understanding and prevent incidents of sexual harassment; and
 - e. Provide referral to the victim of sexual harassment/GBSH (counseling, referral, etc.)
- **5.** The members of the Division CODI shall serve a term of two (2) years unless earlier revoked.
- 6. Wide and immediate dissemination of this memorandum is desired.
