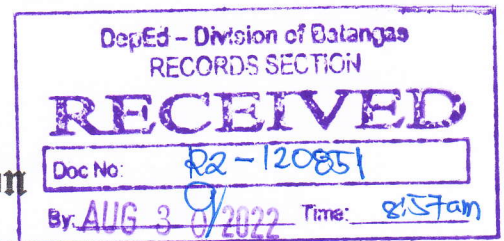

1. Relative to the implementation of Results-Based Performance Management System, please be informed that the following teaching and non-teaching personnel are required to submit their SY 2021-2022 OPCRF and IPCRF for approval of the Schools Division Superintendent and Administrative Officer V in case of non-teaching personnel:
 - 1.1 All school heads of elementary, junior high schools and senior high schools including TICs (OPCRF)
 - 1.2 All Master Teachers and department heads of elementary, junior high schools and senior high schools (IPCRF)
 - 1.3 All school-based non-teaching personnel (IPCRF)
2. The accomplished SY 2021-2022 OPCRF/IPCRF is expected to be submitted to this Office on or before September 2, 2022. It is requested that these OPCRF/IPCRF be submitted by district. **Individual submission will not be accepted.**
3. Accomplished OPCRF and IPCRF shall include the following which was already discussed and deliberated with the rater:
 - 3.1 Part I. Office/Individual Performance Commitment and Review Form
 - 3.2 Par 2. Competencies Rating
 - 3.3 Part 3. Summary of Ratings for Discussion
 - 3.4 Part 4. Development Plans
4. In addition, all districts are directed to submit to this Office two (2) copies of the **Notarized School Summary of the Final Rating** (see attached), compiled in separate folders (elementary, junior high schools and senior high schools). Deadline of submission is on September 7, 2022. **Individual school's submission will not be accepted.**
