

KOOP QUIZ 12TH BLAST

OBJECTIVES:

1. To bring awareness on the significance and contribution of Cooperatives to social and economic development.
2. To be able to influence the schools in enterprise development through cooperatives.
3. To encourage the students to take part in cooperative activities movement for the next generation of leaders.

GENERAL GUIDELINES AND MECHANICS OF IMPLEMENTATION

1. The KOOPQUIZ 12TH Blast shall be facilitated by the LGUs through the Cooperative Development Officers, or equivalent / designated City/Municipal Cooperative Development Officer and/or Local Cooperative Development Council (LCDC).
2. The competition shall be participated in by Grade 10 students both from public and public schools all over Batangas Province.
3. City/Municipal CDOs are in charge in the selection of their city/municipal representative to the Provincial Level Competition who shall come from the result of simultaneous elimination round in their level on **September 29, 2023**. The elimination round could be face to face or virtual as what is being allowed in the area.
4. Prescribed Entry Form shall be submitted by the participating schools to the City/Municipal CDOs duly signed by the student and his or her adviser/trainor not later than September 14, 2023.
5. The Provincial Level competition shall be on October 12, 2023 (Thursday) at the Conference Room of PCLEDO, Capitol Site, Batangas City.
6. The LGU shall submit the name of the official representative to the Provincial Level Competition using the prescribed entry form to PCLEDO not later than October 3, 2023 (Wednesday) which shall be signed/indorsed by the City/Municipal CDOs.
7. The students shall wear their respective school uniforms and IDs during the contest proper.
8. No entry fee shall be collected

9. Awarding of winners shall be held after the Provincial Level Championship (during the Culmination of the Cooperative Month Celebration)
10. All contestants (Provincial Level) shall be awarded Php 2,000 each which shall serve as their cash incentive being the winner-representative of the city/municipality.
11. The provincial winners shall be declared and shall receive the following:
- KOOPQUIZ 12TH BLASTER TITLES:
- KOOPQUIZ Champion - Trophy/ Medal + ₱10,000 Cash
- KOOPQUIZ 2nd Placer – Trophy/Medal + ₱ 7,000 Cash
- KOOPQUIZ 3rd Placer –Trophy/Medal + ₱ 5,000 Cash
12. The trainer/adviser of the student-contestant and the Local Cooperative Development Officer will also be given a Certificate of Recognition.

SPECIFIC GUIDELINES

1. All questions shall revolve around COOPERATIVE matters and the Batangas Province and Batangas Cooperatives' General Information only. References will include but are not limited to the following:
- RA 9520 AND its implementing Rules and Regulations
 - CDA, Memorandum Circulars
 - Republic Act No. 11364 "Cooperative Development Authority Charter of 2019"
 - Republic Act No. 11535 "An Act Making the Position of a Cooperative Development Officer Mandatory in the Municipal, City and Provincial Levels."
2. The questions shall be categorized and given points as follows:

3. Set of Questions for the City/Municipality Level Elimination Round will be formulated and provided by PCLEDO.
4. All questions shall be in English.
5. The contestants shall be given time limit to answer each question.
6. The contestants shall be evaluated based on points garnered. The highest scorer shall be declared winner.
7. In the event of tie, three (3) difficult questions shall be asked and the results shall determine the ranking. In case of ANOTHER TIE, KNOCK OUT SYSTEM shall be applied. The questions shall be drawn from the set of clinchers.
8. There will be a Board of Judges to determine the accuracy / validity of the answers of the contestants.
9. Protest/s on questions, and related clarification shall be immediately brought to the attention of the Board of Judges for resolution. But questions / protests on previous questions, answers and decisions shall no longer be entertained by the BOJ. The decision of the BOJ shall be final.
10. Only the contestant / official coach can raise questions or protest.
11. The Coop Guardians shall be responsible on the following:
 - a. Information dissemination and invitation of participants;
 - b. Provision of the requirements of the competition: venue, supplies, quiz master, board of judges, etc.
 - c. Adoption of its own scheme in the conduct of the contest proper, but shall not be in conflict with the general guidelines provided;
 - d. Setting up of practical, appropriate and responsive arrangement for coordination in all stages of the implementation of this particular activity.
