DIVISION ONLINE ORIENTATION ON DEPED ORDER NO. 12, S. 2026

TO: Assistant Schools Division Superintendents
Chief Education Supervisors, SGOD and CID
Concerned Education Program Supervisors
Public Schools District Supervisors
Private Senior High School Heads
All Others Concerned

1. Pursuant to **DepEd Order No. 12, s. 2026**, titled “**Government Recognition of Private Basic Education Institutions Offering the Senior High School (SHS) Program,**” the Schools Division Office of Batangas shall conduct a **Division Online Orientation** on **June 23, 2026, 9:00 am onwards** via **Microsoft Teams**.
2. The activity aims to:
 - a. orient private school personnel on the salient provisions of DepEd Order No. 12, s. 2026;
 - b. clarify the requirements, procedures, and standards for securing Government Recognition of private basic education institutions offering the SHS Program;
 - c. discuss the roles and responsibilities of schools and education officials in ensuring compliance with the policy; and
 - d. provide a venue for addressing concerns and clarifications regarding the implementation of the Order.
3. Participants to this activity shall include private Senior High School administrators, SHS principals, registrars, designated school representatives, and concerned personnel from the Schools Division Office.
4. The meeting link and other activity details shall be disseminated through official communication channels prior to the conduct of the orientation.
5. In addition, all private basic education institutions intending to offer the Senior High School Program are encouraged to submit their applications for Government Recognition to the Schools Division Office from **June 22, 2026 to November 27, 2026**. Early submission of applications is highly encouraged to allow sufficient time for evaluation, validation, and compliance with documentary requirements and to ensure that applications are endorsed and processed within the prescribed regional timeline. Schools are advised not to wait until the deadline to avoid delays that may affect the issuance of Government Recognition



