1. Pursuant to DepEd Memorandum No. 050, s. 2025 entitled Learners Health Assessment and Screening and DepEd Order No.9 series of 2026, guidelines on the implementation of the three-term school calendar in basic education. Implementation of all health-related activities such as dental health services, health inspection of learners and the likes shall be strategically scheduled to minimize, if not eliminate disruption to instructional time
2. The school shall secure LHAS consent of all enrolled learners before July 31, 2026.
3. School Heads and assigned sub office nurse are encouraged to coordinate with the Dentist-in-charge of each sub-office regarding the application of fluoride varnish and oral examination to learners specifically from Key Stage 1 (Kinder to Grade 3).
4. All activities shall be properly documented and reported in accordance with existing guidelines and protocols.
