1. Pursuant with Republic Act No. 10611 (Food Safety Act of 2013) - Mandates the protection of public health through the regulation of food safety from production to consumption and requires food handlers to undergo appropriate training on food safety and sanitation, and Republic Act No. 11037 (Masustansyang Pagkain para sa Batang Pilipino Act) - Institutionalizes the School-Based Feeding Program and emphasizes the importance of providing safe and nutritious food to learners to combat malnutrition, the Office of the Schools Division is mandated to ensure the delivery of quality, safe, and learner-centered basic education by providing leadership, supervision, and technical assistance to schools within its jurisdiction. This includes safeguarding the health, safety, and overall well-being of learners and personnel by enforcing policies, standards, and programs related to school operations, including food safety and sanitation in school canteens and feeding programs. In line with this, the Schools Division of Batangas through the School Governance and Operations Division (SGOD) - School Health and Nutrition Unit, shall conduct a Food Safety Training for All Food Handlers on July 7-9, 2026 at NDN Resort and Events Place, Talisay, Batangas.

2. This activity is to strengthen the capacity of schools within the division to implement effective food safety, sanitation, and safe service practices that protect learners from foodborne illnesses and promote a healthy, safe, and supportive learning environment.

3. The participants in this activity are the Food Handlers of the school (see Annex B for the List of Participants).

4. This Memorandum serves as Travel Order of the participants.

5. Expenses related to the conduct of this activity shall be charged against the SBFP Funds; while travelling and incidental expenses of the participants shall


