COORDINATION MEETING OF SENIOR HIGH SCHOOL HEADS

1. In view of the urgent matters concerning the implementation of the Technical Professional (TECHPRO) Track in schools, this Office shall conduct a **Coordination Meeting** for all School Heads of Senior High Schools offering TECHPRO on **July 29, 2026, at 9:00 a.m. onwards** at the **Taal Central School, Taal Sub-Office, Taal Batangas**.

2. This meeting aims to:

- Finalize and ensure the completeness, accuracy, and compliance of all documentary requirements for the application of Special Orders for the newly offered electives under the Technical Professional (TECHPRO) Track;
- Provide updates on the status of applications for Assessment Centers, including requirements, compliance concerns, and timelines for approval;
- Present and review the National Certificate (NC) Assessment accomplishments for School Year 2025–2026, highlighting assessment performance, certification results, and identified challenges encountered by schools;
- Discuss issues, concerns, and best practices related to the implementation of TECHPRO programs and the conduct of competency assessments; and
- Formulate appropriate interventions, strategies, and action plans to address gaps and challenges in NC assessment implementation and to improve the certification rate of learners

3. All participants are requested to bring their **laptops and other relevant documents/data pertinent to the TECHPRO implementation, NC assessment, Special Order applications, and Assessment Center applications** to facilitate the discussion, validation of reports, and preparation of action plans during the meeting. Additionally, all participants are advised to bring their own food for the duration of the activity.
