

KOOP QUIZ 13TH BLAST

OBJECTIVES:

1. To bring awareness on the significance and contribution of Cooperatives in social and economic development.
2. To be able to influence the schools in enterprise development through cooperatives.
3. To empower the students to take part in cooperative activities movement for the next generation of leaders.

GENERAL GUIDELINES AND MECHANICS OF IMPLEMENTATION

1. The KOOPQUIZ 13TH Blast shall be facilitated by the LGUs through the Cooperative Development Officers, its equivalent / designated City/ Municipal Cooperative Development Officer / Local Cooperative Development Council (LCDC).
2. The competition shall be participated in by Grade 10 students both from public and public schools all over Batangas Province.
3. City/Municipal CDOs are in charge on choosing of their city/municipal representative in the Provincial Level Competition which is the result of simultaneous face-to-face elimination round in their level on **September 25, 2024**.
4. Prescribed Entry Form shall be submitted by the participating schools to the City/Municipal CDOs duly signed by the student and his or her adviser/trainer not later than September 5, 2024.
5. The Provincial Level competition shall be on **October 18, 2024 (Friday)** at the Provincial Cooperative Development Center, Capitol Site, Batangas City.
6. The LGU shall submit the name of the official representative on the Provincial Level Competition using the prescribed entry form to the PCLEDO not later than October 2, 2024 (Wednesday) which shall be signed/indorsed by the City/Municipal CDOs.

7. The contestants shall wear their respective school uniforms and IDs during the contest proper.
8. No entry fee shall be collected
9. Awarding of winners shall be held after the Provincial Level Championship
10. All contestants (Provincial Level) shall be awarded Php 2,000 each which shall serve as their cash incentive being the representative of the city/municipality.
11. The provincial winners shall be declared and shall receive the following:

KOOPQUIZ 13TH BLASTER TITLES:

KOOPQUIZ Champion - Trophy/ Medal 12,000 Cash

KOOPQUIZ First Runner –up – Trophy/Medal + ₱ 10,000 Cash

KOOPQUIZ Second Runner–up –Trophy/Medal + ₱ 7,000 Cash

12. The trainer/adviser from where the representative came from and the Local Cooperative Development Officer will also be given a Certificate of Recognition.

SPECIFIC GUIDELINES

1. All questions shall revolve around COOPERATIVE matters and Batangas Province and Batangas Cooperatives General Information only. References will include but are not limited to the following:
 - RA 9520 AND its implementing Rules and Regulations
 - CDA Memorandum Circulars (2009-2024)
 - CDA's website (www.cda.gov.ph)
 - Republic Act No. 11364 "Cooperative Development Authority Charter of 2019"
 - Republic Act No. 11535 "An Act Making the Position of a Cooperative Development Officer Mandatory in the Municipal, City and Provincial Level."
2. The questions shall be categorized and given points as follows:

3. Questions for the City/Municipality Level Elimination Round will be uniform which will be coming from PCLEDO.
4. All questions shall be in English.
5. The contestants shall be given time limit to answer each question.
 - Easy – 10 seconds*
 - Average – 15 seconds*
 - Difficult – 20 seconds*
6. The contestants shall be evaluated based on points garnered. The highest scorer shall be declared winner.
7. In the event of tie, three (3) difficult questions shall be asked and the results shall determine the ranking. In case of ANOTHER TIE, KNOCK OUT SYSTEM shall be applied. The questions shall be drawn for the set of clinchers.
8. There will be a Board of Judges to determine the accuracy / validity of the answers of the contestants.
9. Protest/s on questions, and questionable answer shall be immediately brought to the attention of the Board of Judges for immediate resolution. But questions / protests on previous questions, answers and decisions shall no longer be entertained by the BOJ. The decision of the BOJ shall be final.
10. Only the contestant / official coach can raise questions or protest.
11. If not conducted on September 25, 2024 (simultaneous elimination round) City/municipal level competition shall not be later than September 30, 2024. The City / MCDO shall closely coordinate with the respective Cooperative Guardian if they will conduct it to assist in handling the following:

- a. Information dissemination and invitation of coop participants;
- b. Provision of the requirements of the competition: venue, supplies, quiz master, board of judges, etc.
- c. Adoption of its own scheme in the conduct of the contest proper, but shall not be in conflict with the general guidelines;
- d. Setting up of practical, appropriate and responsive arrangement for coordination in all stages of the implementation of this particular activity.
