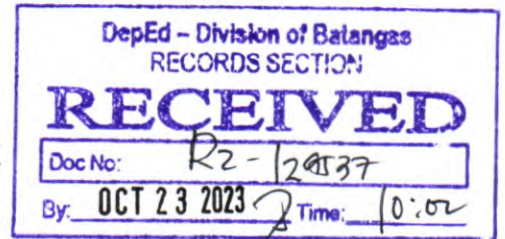

- a. Maintain an Operation and Monitoring Center to document and report all teacher and school-related issues and concerns before, during and after elections;
 - b. Ensure that teachers are provided with and/or referred to adequate information, technical and legal assistance in the course of the performance of their duties as members of Election Board
 - c. Serve as DepEd Institutional link to volunteer organizations and individuals;
 - d. Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, and partner agencies involved in the 2023 BSKE; and
 - e. Complement the other government agency's efforts for an honest, orderly, and peaceful election;
4. Expenses for establishing and operating the Division Election Task Force Command Center and payment of overtime pay to qualified personnel who compose the Division Election Task Force shall be charged against SDO funds, subject to existing accounting and auditing rules and regulations.
5. Immediate dissemination of and strict compliance of this memorandum is directed.
