1. Pursuant to Regional Memorandum ESSD Memo – 2026 – 60, dated June 25, 2026 re: Guidelines on the Implementation of Learner Rights and Protection (LRP) on Wheels 2026, this Office, thru the Learner Rights and Protection Division (LRPD) of the School Governance and Operations Division (SGOD) shall conduct the abovementioned activity on September 8 2026, to be held at Anselmo A. Sandoval Memorial National High School, P. Balibaguhan, Mabini, Batangas.
2. This activity aims to promote awareness and deepen understanding of Learner Rights and Protection services in preventing and addressing bullying and violence in schools.
3. Participants in the said activity are the Sub-Office Learner Rights and Protection (LRP) Focal Persons together with their SELG and SSLG Presidents and Vice Presidents, selected Guidance Counselors, and Division Learner Formation Coordinators. Please see the attached list of participants (Annex A).
4. Likewise, all SELG and SSLG officers participating in this activity shall serve as the Learner Rights and Protection (LRP) Learner Representatives of their respective Sub-Offices. All participants are required to submit the duly signed Parent Consent Form to their respective School Heads prior to the conduct of the activity. They are likewise encouraged to bring their own travel mug or tumbler. Participants may wear their official organization shirt paired with decent, non-faded pants. Ripped or distressed jeans are strictly prohibited. Please refer to **Annex D** for the Parent Consent Form.
5. The Division Learner Rights and Protection (LRP) Focal Person shall:
 - a. conduct an ocular inspection of the venue, and visit the venue as necessary, to ensure the readiness of the facilities and logistical requirements.
 - b. meet with the Division Federated Supreme Secondary Learner Government (SSLG) President in their school at a mutually convenient time outside of class hours to discuss the assigned topic, ensuring that instructional time is not disrupted.

Furthermore, an online coordination meeting shall be conducted with the Sub-Office LRP Focal Persons, TWG and Learner Led Facilitators prior to the activity to discuss the program flow, roles and responsibilities, and other pertinent preparations to ensure the smooth and successful implementation of the activity.

6. Travel Expenses of the Division LRP Focal shall be charged to SUB-ARO while the school personnel and learners shall be charged to respective School MOOE / local funds. Other SDO personnel shall be charged to Division MOOE subject to usual accounting and auditing procedures

7. This memorandum also serves as the authority to travel of the school personnel participants and SDO personnel participant
