Pursuant to DepEd Order (DO) No. 21, s. 2019, titled Policy Guidelines on the K to 12 Basic Education Program, which stipulates that through the Special Curricular Program (SCPs), it is envisioned that DepEd will produce a globally-competitive learners imbued with desirable values and equipped with 21st century skills that contribute to nation-building and national transformation while preserving Filipino culture, heritage and identity, the Department of Education through the Bureau of Curriculum Development (BCD) announces the Special Curricular Program-Program Support Fund (SCP-PSF) for SY 2024-2025.
2. The Program Support Fund (PSF) aims to enhance the operation of each of the special curricular programs and augment MOOE of all recognized SCP elementary and secondary schools. Specifically, it intends to enhance access and improve the quality of SCP programs and services, as well as to raise the efficiency of their operations by creating mechanisms of support and structure both in the instructional and logistical aspects.
