#### ESTABLISHMENT OF LEARNER RIGHTS AND PROTECTION DESK DURING THE CONDUCT OF THE SY 2025 - 2026 ATHLETIC MEET AND OFF - CAMPUS ACTIVITIES

- 1. Relative to DepEd Memorandum No. OUOPS-2025-11-00521, this Office through the School Governance and Operations Division (SGOD), directs all public and private schools to establish a Learner Rights and Protection Desk (**LRPD**) in their respective schools during the conduct of the SY 2025 2026 sporting events, including regional, division, and school meets, as well as other off-campus activities such as the Festival of Talents (FOT) and the Schools Press Conference (SPC).
- 2. This aims to:
  - a) Conduct consultation and coordination with the LRPD, appropriate school governance level, and concerned stakeholders to ensure the safety and protection of participating learners;
  - b) Conduct psychological first aid;
  - c) Provide immediate response to reported LRP incidents;
  - d) Provide 4Rs of child protection (recognize, record, report, and refer);
  - e) Conduct pre-orientation on the code of conduct for coaches, trainers, chaperones/guardians, including their roles and responsibilities in ensuring the protection of our learner-athletes; and
  - f) Provide report to the regional office, Schools Division Office, and LRPD on the LRP incidents handled.
- 3. The Division LRPD Committee shall be composed of the following to oversee the operationalization of LRP Desk during sporting events, including regional, division, and school meets, as well as other off-campus activities such as the Festival of Talents (FOT) and the Schools Press Conference (SPC):

The School LRP Focal Person shall ensure the timely submission of the Activity Documentation Report relative to the conduct of the pre-orientation on the Code of Conduct for coaches, trainers, and chaperones/guardians. - 5. Moreover, the CPCs in schools are requested to convene as LRPD for their respective schools ensuring the safety of our learners in their playing venue.

- 7. Travel Expenses of school personnel shall be charged to respective School MOOE / local funds while the Division LRP Focal shall be charged to Division MOOE subject to usual accounting and auditing procedures.
