1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will administer the Programme for International Student Assessment (PISA) (PISA)- Based Test for Schools 2026, pursuant to DepEd Order No. 29, s. 2017, titled Policy Guidelines on System Assessment in the K to 12 Basic Education Program.
2. Relative to the foregoing, funds intended to support the implementation of the PISA-Based Test for Schools 2026 shall be downloaded directly to the participating schools, subject to **existing budgeting, accounting, auditing, procurement, and financial management rules and regulations**. The specific fund allotment for each participating school is provided in the Enclosure of this Memorandum.
3. The participating schools shall ensure that the downloaded funds are utilized solely for authorized and necessary expenses directly related to the implementation of the PISA-Based Test for Schools 2026, consistent with the approved allocation and existing government accounting and auditing policies.
4. The specific fund allotment for each participating school is indicated in the Enclosure to this Memorandum. School heads and designated personnel are advised to carefully review the corresponding allocation and ensure that all expenditures are properly supported by the required documentation.
