1. Relative to Regional Memorandum No. 623, s. 2025, this Office enjoins the participation of the identified learners and personnel listed in the enclosure to the 2025 Regional Disaster Risk Reduction and Management (DRRM) Olympics, to be held on September 26–27, 2025, at the Alcala Sports Complex, Quezon.

2. The activity aims to intensify effort to provide learners with knowledge, capacity, and education in times of hazardous events, emergencies, disasters, or crises. Moreover, this is to showcase learners' ability to respond to emergencies, particularly to first aid and firefighting.

3. As outlined in **Enclosure 1**, the list of participating schools along with the corresponding number of learners per event has been provided. In line with the preparation for the upcoming activities, all participating schools are required to observe the following guidelines:

- a. **Review of Assigned Participants.** All assigned coaches for each activity must verify the number of learners assigned to each event as indicated in *Enclosure 1*. Any discrepancies or necessary adjustments must be reported immediately to the SGOD-DRRM office.
- b. **Inter-Agency Coordination.** Schools are expected to actively coordinate with relevant agencies, local government units, and community stakeholders to ensure logistical and operational support for their learners during practices and the actual event.
- c. **Practice and Rehearsals.** All participants must be given ample opportunity to practice for their respective events. Schools are advised to schedule practice sessions during available time slots that do not conflict with regular classes and academic activities. Flexibility and creativity in scheduling are encouraged to optimize training time without compromising instructional hours.
- d. **Supervision and Support.** Coaches/designated school personnel must supervise all practices. Safety, discipline, and proper conduct must be ensured at all times.
- e. **Communication and Updates.** All participants must maintain open lines of communication with the organizing committee for updates, clarifications, and

further instructions. Regular monitoring and feedback may be conducted to assess readiness and address any concerns.

- f. **Compliance and Responsibility.** All participants are expected to adhere strictly to these instructions. The overall success of the activity depends on the commitment and collaboration of everyone involved.

4. All listed participants must complete the registration and submit all required permits on or before *September 1, 2025*, at 12:00 noon. The registration will be done online through a link that will be shared by the Division DRRM Focal Person via the official communication platform.

5. This memorandum shall also serve as the travel order for all concerned personnel and participants involved in the activity.

6. Expenses relative to this activity shall be charged against DPRP fund and respective MOOE/local funds, subject to usual accounting and auditing rules and regulations.
