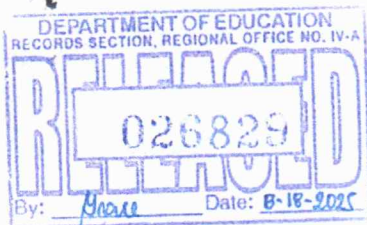

**SEARCH FOR THE BEST INFOMERCIAL ON OPLAN

To **Schools Division Superintendents**

1. Pursuant to DepEd Order no. 28 s. 2018¹, and with the continuous effort to showcase the effective implementation of the Oplan Kalusugan sa Department of Education (OK sa DepEd), the Education Support Services Division – School Health Section is launching the “Search for the Best Infomercial on OK sa DepEd Implementation.”
2. OK sa DepEd is the convergence of DepEd’s health programs, plans, policies and activities for the effective and efficient implementation at the school level, in partnership with various stakeholders focusing on School –Based Feeding Program (SBFP), National Drug Education Program (NDEP), Adolescent Reproductive Health Education (ARH), Water, Sanitation and Hygiene (WASH) in Schools (WinS), and Medical, Dental and Nursing Services (MDNS).
3. This search aims to document and highlight the best practices, accomplishments, and impact of the OK sa DepEd in various schools in CALABARZON.
4. Each Schools Division Office (SDO) shall select one (1) participating school to represent their division and comply with the following technical requirements:
 - a. Video Duration: With a maximum of 3 minutes
 - b. File Format: MP4 (high definition, at least 1080p resolution)
 - c. Audio Quality: Clear voice-over or narration with audible background music (if applicable)
 - d. Video Orientation: Landscape
 - e. Content Must Include:
 - i. The 6 Flagship Programs of OK sa DepEd
 - ii. Activities conducted related to the programs
 - iii. The objectives of the OKD Program
 - iv. The impact and outcomes of the implemented activities

2. Relevance and Impact	<ul style="list-style-type: none"> Demonstrates clear alignment with the goals of the OKD Program and shows visible impact to the learners applicable for the whole CALABARZON region 	30
3. Creativity and Presentation	<ul style="list-style-type: none"> Shows an engaging presentation style and creative visuals. Information is well-organized and easy to follow; smooth flow from beginning to end. 	25
4. Technical and Audio Quality	<ul style="list-style-type: none"> Adheres to video format (MP4), duration (maximum of 3 minutes), and resolution (at least 1080p), video is in landscape orientation. Voice-over or narration is clear; background music enhances rather than distracts. 	15
