The PRISAB Sports Competition aims to foster physical fitness, discipline, sportsmanship, and camaraderie among student-athletes of private schools in Batangas. It also seeks to showcase talents, uphold excellence and fair play, and promote school pride and holistic development through healthy competition.

In this regard, the association needs officials for the Swimming Competition which will be held at Balayan Aquatic Center on September 20 (Saturday). We know that DepEd Division of Batangas has a pool of officials who can assist us for the said competition. Thus, it is our request that we be allowed to ask for the assistance from our pool of officials of DepEd for

May we know the details of this partnership like the fee for the officials and other things that they may be needing or requiring? Below are the guidelines and details of the NAPSPHIL National Swimming Competition as taken from the NAPSPHIL Sports Competition Guidelines.

H. SWIMMING:

- One start rule will be enforced.
- The competition will be in timed/finals format
- 3. Each swimmer may compete to a maximum of 5 events only.
- 4. Each province may only send a maximum of 3 swimmers in each event
- The top 3 swimmers in each event will be awarded 1^{rt} , 2^{rd} and 3^{rd} place. The attire for the males should be cycling shorts or swimming trunks while for the females, it will be one- piece sleeveless swim wear.
- Only athletes, coaches, and delegation officials will be allowed in the designated areas.
- The official manual time of a swimmer shall be determined as follows
- If the time of the first swimmer is higher than the time of the second swimmer, the average time of the two swimmers shall be the official time for both swimmers
- Official placing will be decided by the judge of finish based on facts and the referee's decision will be indicated in the official results.
- The feet of the swimmers must touch the wall or make contact with the wall as they turn to tumble.
- Swimmers who will complete in the butterfly or breaststroke must touch the will with both hands when they turn.
- 11. All entries must be written on the official entry form.
