1. In accordance with the DepEd Advisory from the Bureau of Education Assessment (BEA) dated November 24, 2025, this Office, through the Curriculum Implementation Division, informs all public and private schools that the **Division Administration of the Mock Test for the Computer-Based National Career Assessment Examination (CB-NCAE) for School Year 2025-2026** shall be conducted on **December 3-5, 2025**.

2. The NCAE shall be administered within the testing window from December 9, 2025 to January 30, 2026 through a computer-based modality. It will be administered to all Grade 10 learners currently enrolled in public and private schools with government permit or recognition.

3. The NCAE is designed to provide guidance to individual learners for their future educational and career choices and to provide a basis for profiling learners' aptitude in the four Senior High School (SHS) Tracks: Academic, Technical and Vocational- Livelihood, Sports, and Arts Design. The results of the NCAE are utilized to support the national framework on career guidance and for entry assessment to specific SHS tracks /strands in all public and private schools.

4. The purpose of this Mock Test is to familiarize students with the testing platform and format, ensuring a smooth and confident experience during the actual examination.

5. To ensure the efficient conduct of the Mock Test, monitoring officials are directed to ensure the testing venue is prepared according to the guidelines, oversee the smooth conduct of the mock test , address any major issues or concerns that may arise and provide Technical Assistance, as indicated in Enclosure 1.
