**DIVISION ORIENTATION ON THE ADMINISTRATION OF THE COMPUTER-BASED NATIONAL CAREER ASSESSMENT EXAMINATION (CB-NCAE) FOR SCHOOL YEAR 2025 -2026**

1. Pursuant to the DepEd Advisory from the Bureau of Education Assessment [BEA] dated November 24, 2025, this Office through the Curriculum Implementation Division, this office informs all public and private schools that the Administration of National Career Assessment Examination (NCAE) for School Year 2025-2026 shall be administered on December 2025 – January 2026.
2. These guidelines aim to ensure smooth, secure and equitable testing while maximizing available resources and minimizing disruptions to school operations.
3. The NCAE shall be administered in two consecutive days through computer-based modality. It will be administered to all **Grade 10 learners** who are currently enrolled in **public and private schools** with a government permit or recognition.
4. The NCAE is designed to provide guidance to individual learners for their future educational and career choices and to provide a basis for profiling learners' aptitude in the four Senior High School (SHS Tracks: Academic, Technical and Vocational- Livelihood, Sports, and Arts Design. The results of the NCAE are utilized to support the national framework on career guidance and for entry assessment to specific SHS tracks / strands in all public and private schools.
5. To efficiently administer the said computer-based assessment and properly organize the pool of Room Examiners who will be selected from other schools, there will be an In-Person Division Orientation on the administration of NCAE on November 28, 2025 at Taal Sub Office Conference, Taal Central School, Poblacion Taal, Batangas.
