Relative to Memorandum OM-OAGA-2021-243 re: **Micro-certification Dissemination Forum for ALS Implementers** which focuses on exploring the feasibility of an alternative form of assessment and credentialing through which ALS learners can gain certificates, this office shall conduct recognition and awarding of micro-certification for ALS learners on December 19, 2025, at Calaca City, Batangas.
2. The Department of Education recognizes the vitality of continuous and sustainable programs to promote accessible and quality education at all levels. Alternative Learning System (ALS) provides opportunities for out-of-school youth and adults (OSYA) learners to develop basic and functional literacy skills and to access equivalent pathways to complete basic education. As such, This activity provides opportunity for recognition of ALS learners who undergone micro-credentialing with specific elements of competencies, enabling them for job application, recruitment and selection.
3. Specifically, this activity aims to:
 - a. acknowledge ALS learners for accomplishing specific elements of competencies through the micro-credentialing;
 - b. provide ALS learners the avenue for recognition through awarding certificate of micro-credentials; and
 - c. Celebrate milestone achievement of ALS learners in completing the necessary competencies for job application, and recruitment and selection.
4. Participants in these activities are the 450 ALS learners-awardees, Education Program Specialists-ALS, select ALS teachers, CID Chief, Division ALS Focal Person, SDO Top Management, and invited guests from Regional and Central offices.
