## 2026 MATH CAMP: AMAZING MATH RACE

The Math Olympiads Training League Inc. (MOTLI) will conduct the 2026 Math Camp: Amazing Math Race in Tagaytay on April 17–19, 2026.

The Camp is a specialized program designed to further enhance advanced mathematical problem-solving skills. It will focus on key areas aligned with the K to 12 Mathematics Curriculum's twin goals of critical thinking and problem solving, covering logical thinking, algebra and arithmetic, number theory, geometry, and combinatorics, in support of the Department's thrust toward academic excellence and global competitiveness.

The event will feature an interactive approach that includes lectures, workshops, and practical activities. Collaboration between teachers and learners ensures that knowledge is actively explored and internalized. Teachers provide scaffolding, feedback, and modeling of problem-solving strategies, while learners contribute curiosity, creativity, and active engagement. This collaborative environment fosters a culture of inquiry, experimentation, and mutual learning, empowering students to view mathematics as a practical and indispensable tool in daily life.

Grades 4–12 learners and mathematics teacher-coaches who are new to Math Olympiad are invited to take part in this event to prepare for national and international competitions, promoting excellence, confidence, and perseverance. Furthermore, teachers are empowered to integrate advanced mathematical concepts into classroom practice, enriching the learning experience across the Division.

Participation of learners and teachers from public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 012, s. 2025, titled Multi-Year Implementing Guidelines on the School Calendar and Activities and DO 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.
