 AND INTERNATIONAL ACADEMIC OLYMPIADS PROGRAM 2026**

The Champions League for Innovation and Learning Inc. (CHAMPLI), in partnership with international Olympiad organizations, invites Kindergarten to Grade 12 learners from both public and private schools to participate in its CHAMPLI-Students Training for Advanced Readiness (STAR) and International Academic Olympiads Program. These will be offered through a blended format on various dates throughout 2026.

The CHAMPLI-STAR Program is a structured pre-Olympiad training and international competition participation initiative designed to enhance Filipino learners' higher-order thinking skills, problem-solving abilities, academic confidence, and global competitiveness. It provides guided review sessions, practice simulations, and mentor-led coaching to prepare students for reputable international academic Olympiads.

International competitions are conducted online or onsite by CHAMPLI's global partner organizations, while training sessions are facilitated locally by CHAMPLI.
