**NUTTY SCIENTISTS PHILIPPINES' IN-SCHOOL SCIENCE PROGRAMS AND EVENTS  
FOR SCHOOL YEAR 2026–2027**

The Nutty Scientists Philippines will conduct its in-school science programs and event offerings for the school year 2026–2027, from July 2026 to March 2027.

The programs aim to further enhance science learning experiences in both public and private schools through the following initiatives:

1. Interactive Science Shows – High-energy, educational science shows bring classrooms to life through dynamic demonstrations that spark excitement and curiosity.
2. Larger Than Life Science Installations – Larger and more visually captivating science installations offer immersive, thematic experiences that make learning both informative and awe-inspiring.
3. Amazing Pocket Science Booths – These compact, interactive setups transform school spaces into mini science hubs that allow for the exploration of bite-sized experiments at one's own pace, encouraging discovery, creativity, and hands-on learning in a fun, open environment.

The activities are grounded in inquiry-based learning and designed to complement classroom instruction through experiential, engaging approaches. Each experience is designed to be memorable, educational, and inspiring, enabling learners to

- observe real science in action;
- ask questions, predict outcomes, and test ideas;
- apply scientific thinking and evidence-based reasoning;
- collaborate, problem-solve, and learn through hands-on experience; and
- discover that mistakes are an essential part of meaningful learning.

Preschool to junior high school learners from both public and private schools are invited to take part in this event to help nurture the next generation of Filipino scientists, innovators, and critical thinkers.

Participation of learners from public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 012, s. 2025, titled Multi-Year Implementing Guidelines on the School Calendar and Activities and DO 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.
