SUSTAINABLE DEVELOPMENT GOALS PEACE AND CLIMATE TECHNO-RESILIART SUMMIT FESTIVAL

The Earthsavers Dreams National International Theatre Institute (ITI) Center Inc., in collaboration with the University of Makati-Center for Culture and the Arts, will host the Sustainable Development Goals (SDGs) Peace and Climate Techno-ResiliArt Summit Festival, to be held at the University of Makati on March 4-5, 2025.

The Summit Festival offers a platform for education stakeholders, policymakers, and cultural leaders to collaborate on sustainable and inclusive climate solutions. The program actively involves leading artist-teachers and communicators dedicated to using the power of the arts for public service.

The event aims to bridge the communication gap on climate science by using performing, visual, and literary arts to raise public awareness and drive action. It encourages inter-agency collaboration to strengthen the country's commitment to the United Nations (UN) 2030 SDGs and the Paris Climate Accord.

The activity aligns with the Congressional Resolution commemorating the 80th Anniversary of the UN, which supports programs that educate and engage communities, especially vulnerable sectors, on climate change and disaster risk reduction. It follows the UN Triangulated Conference on Youth, Indigenous Peoples, and Labor Rights, hosted at the Senate in August 2024, and serves as a national mobilization effort leading to COP 30 in Belem, Brazil, where the Philippines aspires to showcase culture-based climate action.

Regional offices will select teachers and learners to attend this event as delegates and encourage their participation.
