**CAREER GUIDANCE AND SCHOOL ARTICULATION ACTIVITIES OF THE NATIONAL
UNIVERSITY PHILIPPINES FOR SCHOOL YEAR 2026–2027**

The National University Philippines (NU) will conduct Career Guidance and School Articulation Activities for public schools for the school year (SY) 2026–2027.

This initiative is part of NU’s commitment to nurturing learners through #EducationThatWorks, anchored in the Nationalian core values, by providing career guidance and information on degree programs and scholarship opportunities for SY 2027–2028. Implementation will be coordinated with selected basic education, junior high school, and senior high school institutions through career talks, college-readiness discussions, and related activities in identified areas during the SY 2026–2027.

The activities may be conducted face-to-face or online, subject to the availability, preference, and existing guidelines of the concerned schools, and shall be scheduled at times most convenient to learners and schools. The proposed regions to visit for the SY 2026–2027 are as follows:
