(NATIONAL SEMINAR-WORKSHOP ON THE TEACHING OF THE RIZAL COURSE)**

The Gurong Nagkamalayang Bayan Inc. invites teachers to its Dalumatan ng mga Gurong Nagkamalayang Bayan, a National Seminar-Workshop on the Teaching of the Rizal Course (Tertiary Level), to be held in the Provincial Farmers Livelihood Development Center, Provincial Capitol, Vigan City, Ilocos Sur, on May 28–31, 2026.

With the theme *Higit pa sa Noli at Fili: Pagpapalalim at Pagpapahusay ng Guro tungo sa Mapagpabago at Makabuluhang Edukasyon!*, the Seminar-Workshop aims to deepen content mastery and further enhance the teaching competence of instructors who handle the Rizal Course through innovative pedagogical approaches. It seeks to equip teachers with strategies to foster deeper, more critical discussions of Dr. Jose P. Rizal's life, works, and ideas, and to connect these to current events in the Philippines, particularly the spirit of nationalism he embodied.

Moreover, the activity will highlight the identified teaching gaps observed in the Rizal course, such as a strong focus on *Noli Me Tangere* and *El Filibusterismo*, the limited use of primary sources, and weaknesses in the application of interactive teaching strategies, including Artificial Intelligence (AI).
