MILO INTER-SCHOOL SHORT COURSE SWIMMING CHAMPIONSHIPS 2026

Building on the success of its inaugural season, the 2nd MILO Inter-School Short Course Swimming Championships, organized by the Bert Lozada Swim School in collaboration with Swim Philippines, will hold its championship legs in North Luzon, Western Visayas, the National Capital Region (NCR), South Luzon, Central Visayas, and Mindanao from August 1 to October 10–11, 2026.

Now in its second season, the MILO Inter-School Championships continue to bring together thousands of student-athletes from public and private schools across the country. More than just a competition, this event serves as a dynamic platform for youth development, nurturing confidence, discipline, sportsmanship, and character among young swimmers both in and out of the pool.
