The Philippine-American Educational Foundation, also known as the Fulbright Commission in the Philippines, is the bi-national commission that administers the Fulbright Program, an academic exchange program that awards scholarship grants for Filipinos to the United States (U.S.). The Fulbright Commission announces the opening of applications for the Fulbright U.S. - ASEAN Visiting Scholarship Initiative Program for the Academic Year 2026–2027. Applications will be open until October 17, 2025.

The Fulbright Program aims to strengthen the relationship and increase mutual understanding between the people of the U.S. and the Philippines by awarding graduate study, lectures, research grants, and research fellowships.

The program is open to university faculty, government officials, and professional staff of think tanks and other nongovernment organizations in ASEAN member nations to travel to the U.S. for scholarly and professional research for three to four months on issues that are relevant and useful to member nations, and central to the U.S.-ASEAN relationship.
