**AMENDMENT TO DEPED MEMORANDUM NO. 090, s. 2022**

(Reconstituting the National Search Committee for Third-Level Positions)

1. Pursuant to DepEd Memorandum (DM) No. 090, s. 2022 titled *Reconstituting the National Search Committee for Third-Level Positions*, the National Search Committee - Screening Committee (NSC-SC) shall supervise and conduct interviews of applicants and/or candidates to Third Level positions, and to perform other relevant tasks as may be assigned by the National Search Committee (NSC.)
