-WITNESSETH-

4. The company shall assign a Point of Contact (POC) to coordinate with MedCity Diagnostic and Medical Center on matters regarding the service.
5. The company shall endorse and schedule the employees for health service to MedCity Diagnostic and Medical Center.
6. The company shall provide a signed Letter of Guarantee (LOG) & accomplished referral slip or an endorsement letter to the employee undergoing health service.
7. Any and all results of the APE of **DepEd** employees shall be treated with utmost confidentiality and shall not be divulged in any manner to any person except in compliance with the law or lawful order of a government entity.
8. Company's point of contact shall make prior endorsement to MedCity Diagnostic and Medical Center for the APE and/or other medical test of its employees.


