

WHEREAS, the Bids and Awards Committee issued Supplemental Bid Bulletin No.1 and No. 2 on November 20, 2023 and November 21 17, 2023 respectively

WHEREAS, in response to the said advertisements, there were nine (9) interested bidders who logged in the Documents Request List of PhilGEPS, however, one bidder availed the bidding documents and submitted its bid manually before 2:00 p.m. of November 2023 at SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, on November 28, 2023 at 2:00 p.m., the opening of bids for manual submission was conducted at SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, during the bid opening, a representative from **Seventh-Day General Merchandise** attended the opening of bids at the SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, the BAC opened the financial component envelope of the bidder and found the following details below:

WHEREAS, on December 6, 2023, at 9:00 a.m., the detailed evaluation of bids of **Seventh-Day General Merchandise** was conducted at the Division Office Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City and the bid amount as calculated is as follows:

WHEREAS, Section 32.2.3 of 2016 IRR of RA9184 updated as of July 3, 2023 states: In case of discrepancies between: 32.2.3 In case of discrepancies between: (a) bid prices in figures and in words, the latter shall prevail; (b) total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; (c) stated total price and the actual sum of prices of component items, the latter shall prevail; (d) unit cost in the detailed estimate and unit cost in the bill of quantities, the latter shall prevail.

WHEREAS, Section 34.4 of 2016 IRR of RA9184 updated as of July 3, 2023 states: If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower;


