WHEREAS, invitations to observers for the pre-bid conference and opening of bids were sent to the Commission on Audit (COA) DepEd Batangas, Bauan Technical High School Multi-Purpose Cooperative and Bolo Multi-Purpose Cooperative;

WHEREAS, on November 13, 2023, at 10:00 a.m. a pre-bid conference was conducted at DepEd SDO Conference Room., Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, on November 28, 2023 at 2:00 p.m., the opening of bids for manual submission was conducted at SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, during the bid opening, a representative from **Seventh-Day General Merchandise** attended the opening of bids at the SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, Section 32.2.3 of 2016 IRR of RA9184 updated as of July 3, 2023 states: In case of discrepancies between: 32.2.3 In case of discrepancies between: (a) bid prices in figures and in words, the latter shall prevail; (b) total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; (c) stated total price and the actual sum of prices of component items, the latter shall prevail; (d) unit cost in the detailed estimate and unit cost in the bill of quantities, the latter shall prevail.

WHEREAS, Section 34.4 of 2016 IRR of RA9184 updated as of July 3, 2023 states: If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower;

WHEREAS, the contract price would be Three Million Four Hundred Twenty-Four Thousand Six Hundred Eighty-Four Pesos (**P3,424,684.00**) instead of Three Million Four Hundred Twenty-Four Thousand Six Hundred Eighty-Four Pesos and 80/100 (**P3,424,684.80**);



CONTRACT AGREEMENT

THIS AGREEMENT made this 27th day of December 2023 between Department of Education Division of Batangas, Provincial Sports Complex, Bolbok, Batangas City, Philippines (hereinafter called "the Entity") represented herein by its Schools Division Superintendent **DR. 


