WHEREAS, On November 28, 2023, the BAC conducted a bid opening for the reposted project, **Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program (SBFP) for SY 2023-2024 with PR No. 2023-08-0079 - Lot1- Php 22,800,960.00, Lot 2- Php. 5,063,040.00, Lot 3- Php. 9,367,920.00, Lot 4-Php. 15,305,760.00, Lot 5 -Php. 3,600,720.00 Lot 6 Php. 2,540,160.00**

WHEREAS, during the bid opening the BAC declared, AICEE CATERING FOOD SERVICES, the Lowest Bid as Read for Lot 1, SEVENTH-DAY GENERAL MERCHANDISE for Lot 5, and AICEE CATERING FOOD SERVICES for Lot 6, and they were declared single calculated responsive bid during post-qualification;

WHEREAS, MORE2 SALES VALUE STORE submitted a bid for Lot 2 and Lot 4 and upon opening of the technical components, it was found disqualified due to the out-of-date PhilGEPS Annex A, Audited Financial Statement (AFS) and was declared non-compliant for Lot 2 and Lot 4, hence the BAC declared the failure of bidding for these lots;

WHEREAS, in Lot 3, no bidder submitted bid documents, hence the BAC declared failure of bidding for this lot.

WHEREAS, due to the 2nd failed biddings of Lot 2, Lot 3, and Lot 4, the BAC, convened on December 22, 2023, 9:00 a.m. to discuss the conduct of procurement of the said project under Section 53.1 of RA 9184 IRR Negotiated Procurement (Two-Failed Biddings);

WHEREAS, on January 17, 2024, the BAC issued a Notice to Conduct Post-qualification to Proverbs' Enterprises JVA with Aicee Catering Food Services, stating that the BAC will conduct an evaluation of eligibility, technical and financial requirements, and sample items to be delivered;

WHEREAS, on January 19, 2024, the BAC and TWG conducted the post-qualification of legal, technical, and financial documents as well as the sample items of Proverbs' Enterprises JVA with Aicee Catering Food Services;

WHEREAS, during the post-qualification AICEE CATERING FOOD SERVICES was found compliant with the technical and financial requirements of the project, However, PROVERBS ENTERPRISES has the following deficiencies.

1. The declared TCC Number in PhilGEPS does not match with their original copy of Tax Clearance.
2. The QR Code in the Mayor's Permit showed a Notice of Award and Notice to Proceed, which are not business details of the Supplier.
3. The PhilGEPS document is not included in the Original Copy of Eligibility/Technical, only in Copies 1 and 2 of Eligibility/Technical.

WHEREAS, the BAC deliberated on the results of the post-qualification submitted by the TWG and after careful verification and comprehensive discussion of the post-qualification report, the BAC decided that PROVERBS ENTERPRISES JVA WITH AICEE CATERING FOOD SERVICES non-compliant for the Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program (SBFP) for SY 2023-2024 with PR No. 2023-08-0079 – Lot 2 (Negotiated Procurement);

WHEREAS, the BAC declared the disqualification of PROVERBS ENTERPRISES JVA WITH AICEE CATERING FOOD SERVICES and recommended the posting of 2nd negotiated procurement of the said project;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to disqualify PROVERBS ENTERPRISES JVA WITH AICEE CATERING FOOD SERVICES for the project Supply and Delivery of Nutritious Food Products for the Implementation of School-Based Feeding Program (SBFP) for SY 2023-2024 with PR No. 2023-08-0079 – Lot 2 and declared failure of Negotiated Procurement.








