**INVITATION FOR NEGOTIATED PROCUREMENT FOR

In view of the two (2) failed biddings, the Department of Education Division of Batangas, Provincial Sports Complex, Bolbok, Batangas City, through the Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the project with an Approved Budget for the Contract (ABC) stated below, under Negotiated Procurement (Two Failed Biddings) extended posting pursuant to 53.1 of 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act (RA) 9184. The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC and which would meet the required minimum technical specification.

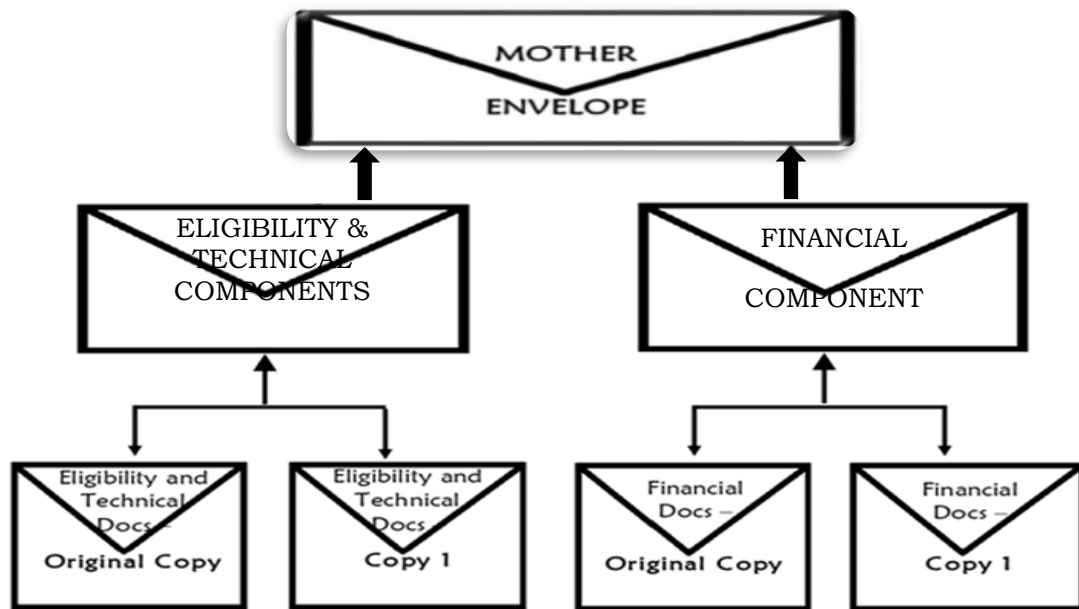
